Consultation on proposed recognition of Ireland Dental Council accredited dentistry programmes

# The proposal

The Dental Council New Zealand is proposing to gazette the Dental Council of Ireland accredited dentistry programmes as prescribed qualifications for the New Zealand general dental practice scope of practice.

A reciprocal agreement between Dental Council NZ and Dental Council of Ireland to accept accredited dentistry programmes, confirm that the jurisdictions recognise the accreditation standards and policies, scopes of practice and competencies as being substantially equivalent to its own, and therefore recognises the accreditation status of education programmes in general dentistry.

This recognition will support graduates from these accredited programmes with easier and streamlined registration pathways.

#### Background

As reported in previous annual reports, Dental Council New Zealand (the Council) embarked on exploring the option of reciprocity between New Zealand and Ireland of its accredited dentistry programmes. COVID-19 interrupted this project.

The validation process for the dentistry programmes has now been completed. The review process included:

- a desktop review of the:
  - o scopes of practice and competencies
  - o accreditation policies, standards and processes
- · observation of accreditation processes and application of standards and policies
- observation of governance and decision-making processes.

Due diligence by each jurisdiction is now complete.

In summary, the scopes of practice and competencies; accreditation policy, standards and processes; are considered comparable between the two jurisdictions. The accreditation and decision-making processes are robust and independent.

Following the validation process to ensure comparable scopes of practice and accreditation regimes, both Councils signed a memorandum of understanding (MOU) to maintain a reciprocal arrangement of certain accredited programmes. The first group of accreditation programmes accepted under the MOU related to general dentistry/general dental practice.

The MOU provides for regular assurance for ongoing recognition. The agreement also provides for future review of other professions recognised across both jurisdictions – such as dental specialist

disciplines (as relevant), dental hygiene and orthodontic auxiliaries, dental and clinical dental technology etc.

Accredited programmes from Dental Council of Ireland are also accepted in Canada<sup>1</sup>, and was recently added by the Dental Board of Australia to the list of recognised overseas dentistry qualifications.

This MOU is similar to the agreement signed earlier between the Council and the Commission on Dental Accreditation of Canada for reciprocity of general dentistry programmes accredited by each authority.

#### What does the proposal mean?

At the moment, the following dentistry programmes are accredited in the two jurisdictions:

- New Zealand: Bachelor of Dental Surgery University of Otago
- Ireland: Bachelor of Dental Surgery (Hons) University College Cork, and Bachelor of Dental Science Trinity College Dublin.

Reciprocity will support graduates from these programmes with easier and streamlined <u>registration</u> <u>pathways</u>. This facilitates easier workforce movement between the two jurisdictions.

In New Zealand, this is achieved by gazetting these qualifications as a prescribed qualification for the general dental practice scope of practice. This signals that the Council consider these qualifications as comparable to New Zealand accredited programmes. This means, graduates from these programmes are considered to meet the entry level competencies for practice in Aotearoa New Zealand.

Similar to any other registrant, other fitness to practice requirements such as ability to communicate adequately in English, health and conduct assurances remain in place.

# Prescribed qualifications for the scope of practice for general dental practice

# New Zealand

- Bachelor of Dental Surgery, University of Otago
- Bachelor of Dental Surgery with Honours, University of Otago.

# Australia

- an Australian Dental Council (ADC) accredited programme<sup>1</sup>
- a Dental Board of Australia approved programme of study providing a qualification for the purpose of registration in general dentistry in Australia<sup>2</sup>
- a five-year undergraduate dental degree and a pass in the Australian Dental Council licensing examinations.

General Dental Council (GDC) accredited dental schools in the UK and Commonwealth countries

• a GDC accredited undergraduate dental degree from a GDC accredited dental school in the UK, or Commonwealth as listed below.

Western Cape	Before 1 January 1998
Hong Kong	Before 1 January 2001

- a five-year undergraduate dental degree and a pass in the National Dental Examining Board of Canada Equivalency Examination Process<sup>4</sup>

 a five-year undergraduate dental degree and a pass in the New Zealand Dental Registration Examinations<sup>5</sup>
