I have been the Clinical Director of the largest practice in New Zealand running up to 16 dentists and 6 hygienists for 16 years. We run a mentoring and peer review system and terminating contracts where people are unable to meet our standards. Even in a cohesive group in one location this a difficult and time consuming exercise. My concerns of the proposals are, 1. A yearly as review as proposed will be unnecessarily time consuming and lacking a long term view of re education and training. I think a 3 yearly cycle would be more workable option. 2. The mentoring system is open to manupulation through mutual agreement. 3. I think a proper practice clinical audit is the only true way of assessing competency of clinicians. 4.A comprehensive review of the eye test component needs to done to assess the steps be used by the practitioner to compensate changes in eyesight.
